Accreditation

CTH is an awarding body approved by Ofqual (Office of qualifications and examination regulation) in the United Kingdom. This being a British qualification, the CTH programmes are not registered with SAQA nor do they appear on the South African NQF. Unigrad College is an approved support centre for the CTH (Confederation of Tourism and Hospitality – United Kingdom). Students write external CTH assessments and are certified by the CTH.
